Benetton Group è un'azienda globalmente responsabile, impegnata nel mantenimento di pratiche di business corrette e sostenibili, il cui impegno si traduce nella continua ricerca di processi e prodotti rispondenti ai più elevati standard di sicurezza per minimizzare l'impatto, sull'uomo e sull'ambiente, di tutte le sue attività produttive.

Nell'ottica di raggiungere un'elevata qualità dei processi produttivi e un'efficiente prevenzione delle possibili non-conformità, risulta fondamentale conoscere l'intera catena di fornitura, ivi compresa quella dei fornitori. Benetton Group, infatti, richiede a tutti i suoi business partner, compresi fornitori e sub-fornitori, di firmare e implementare il Codice di Condotta di Benetton Group, che include i seguenti punti:

- Standard lavorativi internazionalmente riconosciuti e luoghi di lavoro sicuri
- Tutela dell'ambiente
- Trasparenza
- Catena di fornitura e conformità.

Il presente documento traduce in pratica alcuni dei principi del Codice di Condotta di Benetton Group e viene sottoscritto da tutti i fornitori che devono rendere note le informazioni relative agli impianti di lavorazione interni ed esterni, nonché di tutte le fonti di materiali e componenti utilizzate per la produzione dei capi Benetton.

Ai fornitori viene inoltre richiesto di adottare un "approccio pulito" (i.e. Clean Factory Approach) ossia, tutti gli impianti e le produzioni, non solo quelle destinate a Benetton, dovrebbero essere realizzate nel rispetto di quanto richiesto e delle "best practices" in materia di salvaguardia; imperativa quindi la divulgazione delle pratiche descritte a tutta la loro supply-chain.

Benetton Group RSL (Restricted Substances List)

In risposta alle crescenti richieste da parte dei consumatori e di stakeholder, Benetton ha ritenuto di fondamentale importanza identificare un elenco di sostanze da limitare e/o proibire nella produzione dei propri capi. Questo elenco prende il nome di Restricted Substances List (RSL) ed è costituito da una parte rivolta ai processi produttivi e una parte rivolta ai prodotti.

Processi produttivi

I limiti di concentrazione accettabili per le sostanze chimiche presenti nelle formulazioni utilizzate nei processi produttivi, sono quelli stabiliti nella ZDHC MRSL che Benetton, in quanto membro di ZDHC, ha deciso di adottare, <http://www.benettongroup.com/en/sustainability/detox/zdhc/>.

Prodotti

Per quanto riguarda i prodotti, siano essi intesi come materia prima, piuttosto che semilavorati o prodotti finiti, l'elenco prende il nome di Product Restricted Substances List (PRSL) e definisce le sostanze ed i limiti previsti per poter considerare i capi conformi ai requisiti richiesti.

La PRSL di Benetton Group è regolarmente aggiornata con informazioni sulle sostanze che man mano vengono ritenute pericolose, utilizzando un principio precauzionale, ed includendo qualsivoglia sostanza definita pericolosa dalle più autorevoli fonti di valutazione del rischio chimico. Benetton descrive il processo di inclusione ed aggiornamento delle sostanze in un esplicito documento denominato "Benetton's Screening Methodology", <http://www.benettongroup.com/en/sustainability/detox/rsl/>.

Benetton Group esegue un numero considerevole di test chimici in modo da eliminare o minimizzare ogni possibile rischio ed assicurare che i parametri siano rispettati, al fine di immettere sul mercato solo prodotti sicuri. I test di sicurezza prodotto, condotti solo presso laboratori accreditati e in accordo con la PRSL, si basano su: conoscenze tecniche, processi e sostanze altamente problematiche, valutazione del rischio, materiali e quantità utilizzate nonché affidabilità di fornitori e sub-fornitori.

Applicando questa procedura e volendo azzerare l'uso di sostanze pericolose, Benetton Group ha deciso di utilizzare, su base volontaria, dei limiti più restrittivi rispetto a quelli stabiliti dalle legislazioni vigenti nei paesi di produzione, distribuzione e vendita dei capi, e da alcuni standard globalmente riconosciuti (e.g. OEKO-TEX).
